FOURTH AMENDMENT TO CHARTER

THIS FOURTH AMENDMENT TO CHARTER ("Amendment") by and between the Board of Education of Frederick County, Maryland (the "Board"), and Monocacy Montessori Communities, Inc. ("MMCI"), collectively referred to as "the Parties" in this Amendment, is dated and is effective on September 24, 2025.

ACKNOWLEDGMENTS

WHEREAS, the Parties established a Charter agreement dated January 27, 2020, for operation of the Carroll Creek Montessori Public Charter School ("CCMPCS"); and

WHEREAS, the term of the CCMPCS Charter agreement was set to expire on June 30, 2025; and

WHEREAS, on June 26, 2025, the Parties extended the existing Charter agreement for a period of two months to August 31, 2025 to allow for the necessary additional time to complete the negotiations over a replacement Charter agreement; and

WHEREAS, on August 27, 2025, the Parties extended the existing Charter agreement for an additional month to September 30, 2025; and

WHEREAS, the Parties continue to engage in good faith negotiations to enter into a replacement Charter agreement and have made significant progress in reaching agreement on the terms therein; and

WHEREAS, the Parties agree that it is necessary and appropriate to extend the existing Charter agreement to allow for the necessary additional time to complete the negotiations over a replacement Charter agreement.

NOW, THEREFORE, in consideration of the promises and mutual covenants and understanding of each of the Parties, the Parties hereby covenant and agree as follows:

- I. The term of the Charter agreement dated January 27, 2020, as amended as described in section I(B), shall be extended from September 30, 2025 to June 30, 2026.
- II. The Charter agreement dated August 10, 2022 shall automatically terminate *nunc pro tunc* to June 30, 2025 upon the execution of a replacement Charter agreement.
- III. All other terms and conditions of the Charter agreement between the Parties shall remain in full force and effect until such time as the Parties reach agreement and enter into a replacement Charter agreement.
- IV. This Amendment may be signed in counterparts, each of which shall be deemed an original, but all of which taken together shall constitute one and the same Amendment.
